Arranging a Will could save thousands of pounds in future tax. The amount of inheritance tax that will be charged from your estate depends on how much you have and also who you leave it to. Minimise your inheritance tax.

## The Benefits of a Managed Will Service (MWS)

For good reason, most people prefer to use a professional document storage solution. If a Will is lost, gets damaged or is interfered with in any way, then it cannot be used. With the Managed Will Service you have peace of mind knowing that your Will is being managed professionally and stored correctly. Please note that the Managed Will Service is optional. However, it gives you and your family the confidence of secure document storage with the following additional benefits:

### 1. Enduring Power of Attorney (EPA – applies to Northern Ireland only):

This document allows you to nominate who you want to make decisions for you should you lose mental capacity. It will save a lot of time and legal costs should such a situation arise. The normal charge per EPA document is £200. This is included when you opt for the Managed Will Service.

### 2. Document Checking Service:

Kennedy Burchill will check all legal documents to help ensure they have been completed correctly.

### 3 Secure Document Storage:

All documents are securely stored in fireproof cabinets away from the home to help protect against loss or damage. Hard copy and an e-copy are sent to you for your records.

### 4. Unlimited amendments to Will:

### COSTS:
